4. The Monthly Composite Fee is inclusive of the Tuition fee, Activity charges, Lab charges, Infirmary and CCTV etc.
5. The above fee does not include the cost of Books and Stationery sets, Almanac, CBSE Examination Fee, School Uniform, School Excursions, Extra Sports/Co-curricular activities beyond school hours, Transport charges, After School Programme and Meals.
6. The fee will be increased annually as per Govt. Norms.
7. Composite Fee will be payable quarterly in advance by 10th day of the First Month of every quarter. Thereafter late fee will be charged with a fine of Rs. 20/- per day.
8. The submission of fee is allowed on a quarterly or annual basis only.
9. In case the cheque is dishonoured/ bounced by the bank, a cheque bounce charge of Rs. 400/- will be imposed.
10. In case of Re- issue of I-Card, Change in route and Deactivation of Transport, Rs. 200/- will be imposed as processing charge.
11. If fee is not deposited within 45 days of the due date the child's name will be struck off from the school rolls.

AWARDS AND SCHOLARSHIP (FOR SESSION 2024-25 Only)

I ACADEMIC SCHOLARSHIP FOR CLASS XI

For Existing Students & New Admission:

Eligibility Criteria: Students scoring minimum 90% Aggregate marks in Class X Examination will be eligible for the scholarship.

1. No. of scholarships –as per the availability of seats.
2. The quantum of scholarship for class XI will be through exemption in Composite Fees for whole year as given below:

Score in X	Scholarship Grant in XI
95% and above	50% on monthly composite fees
90% to 94.9%	25% on monthly composite fees

II ACADEMIC SCHOLARSHIP FOR CLASS XII

1. If any student scores 95% and above in class XI final examination (only theory) – exemption in Composite Fees (50% discount) will be given in class XII for the whole year.
2. If any student scores 90% to 94.9% in class XI (Final exam theory) exemption in Composite Fees (25% discount) will be given in class XII for the whole year.

III SPECIAL SCHOLARSHIP FOR STUDENTS EXCELLING IN CLASS X & XII BOARD EXAM.

1. Overall Topper of the state - Rs. 1 Lakh.
2. Overall Topper of City - Rs. 50,000/-

(In class X, these scholarships will be awarded to those children who qualify the scholarship criteria and will continue till class XII).

- (1) All rights for grant of scholarship are reserved with the School Management.
- (2) In case a student qualifies for more than 1 scholarship scheme – only one with highest benefit will be applicable.
- (3) Parents can collect the scholarship Application Form from the school's reception and submit it.
